#### Chapter 94 Report:

Vice-Chairman Neal Smith motioned to have Gannett Fleming, Inc., with the assistance of the PTMA office, complete the 2009 Chapter 94 Report as presented in an amount not to exceed \$2,700.00. Assistant Secretary/Treasurer James Newman seconded the motion and unanimously approved.

#### EAST SNYDER PARK:

Chairman Thomas Ferry stated that he has nothing new to report on the East Snyder Park. Further discussion was tabled until the next PTMA meeting.

#### CHAIRMAN'S REPORT By Thomas Ferry:

#### Water Protection Committee Meeting:

Chairman Thomas Ferry reported on the January 6, 2010 Water Protection Committee meeting held at the Selinsgrove Borough Office. Chairman Ferry further reported that PTMA and the Borough of Selinsgrove may be eligible for a \$5,000.00 grant from the League of Women Voters, which could be used to offset the cost of water protection area signs, educational flyers and educational materials that could be used in the local schools.

#### Motion Amendment:

Chairman Thomas Ferry reported that he and Assistant Secretary/Treasurer James Newman purchased a twelve-month \$500,000.00 certificate of deposit as directed by the Authority; however, all interest rates fell below the 1.75% rate stated in the December 3, 2009 motion. After a brief discussion, Vice-Chairman Neal Smith motioned to amend the December 3, 2009 motion to purchase a twelve-month \$500,000.00 certificate of deposit and an eighteen-month \$500,000.00 certificate of deposit from a financial institution that is willing to collateralize both certificate of deposits and offer a rate of **1.59%** or higher. Assistant Secretary/Treasurer James Newman seconded the motion and unanimously approved.

#### VICE-CHAIRMAN'S REPORT By Neal Smith:

#### Local Municipality Sewer Rates:

Vice-Chairman Neal Smith presented a newspaper article that listed the current sewer rates of the local municipalities. It shall be noted that PTMA has one of the lowest sewer rates in the local area.

#### Water Fund Loan – Interest Calculation:

The Authority members discussed the interest calculation for the inter-company loan from the Sewer Fund to the Water Fund. It shall be noted that the original loan was established when the PTMA Water System was built at which time very little interest was paid to the sewer fund. The balance of the loan increased substantially when additional funds were loaned to the Water Fund for the PTMA Water System Consolidation Project. It shall be also noted that no interest has been paid to the Sewer Fund since 1994. Further discussion was tabled until the next PTMA meeting.
