#### **MINUTES:**

The Authority members reviewed the minutes of the March 1, 2012 PTMA meeting. A motion was made by Vice-Chairman Neal Smith to approve the minutes from the March 1, 2012 Penn Township Municipal Authority meeting as presented. # PTMA Office Lease Agreement - David Herbert, Keystone Building Products, Inc.:

The Authority reviewed the March 15, 2012 addendum to the Authority's office lease agreement with Keystone Building Products, Inc. After a brief discussion, Assistant Secretary/Treasurer James Newman motioned to enter into a three-year office lease agreement extension with Keystone Building Products, Inc. in the amount of \$450.00 per month with all other provisions remaining the same as presented in Keystone Building Products March 15, 2012 letter. ### PTMA INSURANCE PACKAGE PROPOSALS:

The Authority members reviewed three insurance proposals from Purdy Insurance Agency, Inc., A.A. Shaffer Jr. & Son Insurance Agency and Sholley Insurance Agency, Inc. After a brief discussion, Assistant Secretary/Treasurer James Newman motioned to accept Purdy Insurance Agency's March 22, 2012 proposal as presented. Secretary Gregory Aungst seconded the motion and unanimously approved. It shall be noted the proposal from Sholley Insurance Agency could not be considered, since a complete proposal was not submitted.

### PTMA COMPUTER SYSTEM:

Assistant Secretary/Treasurer James Newman reported that the current PTMA office computer system is showing signs of age, and will need to be replaced in the near future. After a brief discussion, Vice-Chairman Neal Smith motioned to purchase a new computer system for the PTMA office in an amount not to exceed \$1700.00. # INSPECTOR'S REPORT – Pete DeWire:

# Wedgewood Gardens Private Sewer Lines:

Inspector Pete DeWire reported that recently there have been 3 sewer line blockages along the Wedgewood Gardens Mobile Home Park's private sewer lines. Inspector DeWire further reported an extensive amount of gravel was found in the private sewer lines, which, if not corrected, has the potential to cause a blockage in the PTMA sewer mains. After a brief discussion, the Authority office was directed to send a letter to Wedgewood MHP, LLC stating it has recently been brought to the Authority's attention that there has been numerous sewer line blockages along the privately owned sewer mains located within the Wedgewood Gardens Mobile Home Park. It shall further state when the sewer lines were repaired, it was noted the sewer laterals were allowing a substantial amount of gravel to enter the sewer system causing a sewage backup in the sewer lines. It shall also state since the gravel is also entering the PTMA public sewer system, PTMA rules and regulations require that all sewer laterals within the Wedgewood Gardens Mobile Home Park be repaired according to PTMA specifications. The aforementioned letter shall request that the above-mentioned sewer laterals be repaired by the property owner and inspected by PTMA Inspector Pete DeWire on or before May 15, 2012. It shall note that Mr. DeWire must be contacted 48 hours **prior** to the repairs being completed. It shall further note that a PTMA Approved Plumbers and Contractors list has been enclosed for the property owners' use.
