CHRIST UNITED METHODIST CHURCH LAND DEVELOPMENT:

Kenneth Estep of Christ United Methodist Church reported that the church is ready to construct the water main extension from Harris Estates to the proposed church site located along Route 522. Mr. Estep further reported the church plans to install a yard hydrant and water meter pit for a pavilion that will be constructed on their property within the next year and plans to build the new church building in approximately six years. After a brief discussion, the Authority instructed Mr. Estep to submit the water main extension shop drawings and material list to the Authority's engineer for review. Upon approval of the shop drawings and material list, the Authority will obtain bids for the water main materials as agreed upon in the Water Main Extension Agreement between PTMA and Christ UMC.

PTMA WELL HOUSE ACCESS ROAD:

Solicitor Robert Cravitz reported the revised Deed of Easement for the proposed PTMA Well House Access Road has been sent to SIDCO for their review, approval and execution. Inspector Pete DeWire presented and discussed the plans for the proposed PTMA Well House Access Road and Well House gate.

BREEZEWOOD, PHASE 1A:

Chairman Thomas Ferry reported that Jay Fulkroad & Sons, Inc. has established water and sewer escrow accounts for the completion of Breezewood, Phase 1A. Chairman Ferry further reported an inspector from Gannett Fleming has been assigned to this project as per Inspector Pete DeWire request. Engineer D. Jeffrey Golding reported the sewer mains previously installed in Breezewood, Phase 1A have been flushed, televised and tested. Engineer Golding further reported the sewer manholes in the above-mentioned phase have failed the vacuum test and will need to be repaired prior to retesting.

Inspector Pete DeWire reported the silver metal posts have been constructed and will be installed around the PTMA manholes located along the Clifford Road sewer trunk line in the near future.
